

# Bizagi Process Modeler – Freeware License Agreement

PLEASE READ THIS SOFTWARE LICENSE AGREEMENT (“LICENSE”) CAREFULLY BEFORE PRESSING THE “AGREE” BUTTON. BY PRESSING “AGREE,” YOU ARE AGREEING TO BE BOUND BY THE TERMS OF THIS LICENSE. IF YOU DO NOT AGREE TO THE TERMS OF THIS LICENSE, PRESS “DISAGREE” AND YOU WILL BE UNABLE TO DOWNLOAD OR USE THE BIZAGI PROCESS MODELER.

## 1. Definitions.

- a. The Bizagi Software. Refers to Bizagi Process Modeler, offered by Bizagi Group Ltd or one of its subsidiaries as Freeware, i.e. available for use without payment of licensing fees. It also includes computer software products owned by suppliers of Bizagi Group Ltd distributed by Bizagi Group Ltd under agreement with the owners of such software.
- b. User. The individual or entity using this product.
- c. License. The right for User to use the Software pursuant to the terms and conditions defined herein. The absence of a license fee shall in no way be an indication of a willingness or desire on the part of Bizagi Lmtd. to place the Software in the public domain. Bizagi Lmtd. intends to retain, and does retain, all intellectual property and ownership rights in the Software.

2. **General.** The Bizagi and any third party software, documentation and any fonts accompanying this License (collectively the “Bizagi Software”) are licensed, not sold, to you by Bizagi Group Ltd or one of its subsidiaries (“Bizagi”) for use only under the terms of this License, and Bizagi reserves all rights not expressly granted to you. The rights granted herein are limited to Bizagi’s intellectual property rights in the Bizagi Software and do not include any other patents or intellectual property rights. You own the media on which the Bizagi Software is recorded but Bizagi and/or Bizagi’s licensor(s) retain ownership of the Bizagi Software itself.

3. **Permitted License Uses and Restrictions.** This License allows you to download and use the Bizagi Software on an unlimited number of computers. User may distribute the Software to third-parties only where such third-parties are aware of, and agree to be bound by, the terms and conditions contained in this Agreement. Such distribution shall include all files associated with the Software. Except as and only to the extent expressly permitted in this License or by applicable law, you may not decompile,

reverse engineer or disassemble the Bizagi Software. You may not modify, network, rent, lease, loan, sublicense, assign or otherwise transfer the Bizagi Software in whole or in part. The Software may not be used to support any third party product without the express written consent of an authorized representative of Bizagi. THE BIZAGI SOFTWARE IS NOT INTENDED FOR USE IN THE OPERATION OF NUCLEAR FACILITIES, AIRCRAFT NAVIGATION OR COMMUNICATION SYSTEMS, AIR TRAFFIC CONTROL SYSTEMS, LIFE SUPPORT MACHINES OR OTHER EQUIPMENT IN WHICH THE FAILURE OF THE BIZAGI SOFTWARE COULD LEAD TO DEATH, PERSONAL INJURY, OR SEVERE PHYSICAL OR ENVIRONMENTAL DAMAGE.

YOU EXPRESSLY ACKNOWLEDGE AND AGREE THAT USE OF THE BIZAGI SOFTWARE IS AT YOUR SOLE RISK AND THAT THE ENTIRE RISK AS TO SATISFACTORY QUALITY, PERFORMANCE, ACCURACY AND EFFORT IS WITH YOU.
